MAJOR RESPONSIBILITIES

OF COACH and BENCH STAFF

1. Must follow the aims and objectives of the Langton and Area Minor Hockey Association (hereby known as LAMHA) as outlined through its constitution and policies.
2. Ensure the objectives are met as outlined in the Manual of Operations of the Ontario Minor Hockey Association.
3. Coach shall strive to ensure Fair Play Codes (see below) are met as set out by the Canadian Hockey Association.
4. Coach shall ensure practices are effective and well-planned.
5. Coach and bench staff shall refrain from the use of foul language during all team functions, both on and off the ice.
6. Coach and bench staff agree to participate only in tournaments approved and /or run by L.A.M.H.A abiding by the rules as set forth by the Board of Directors and / or their delegates.
7. Coach and bench staff shall be responsible for all equipment used on and off the ice.
8. Coach and bench staff are responsible for obtaining police background check and providing to Langton and Area Minor Hockey.
